ESTABLISHMENT OF NATIONAL JUDICIARY SPECIALISED SUPPLY AND TENDERS BOARD

I, Hon. James Marape, MP, Minister for Finance, by virtue of the powers conferred on me by Section 39A of the *Public Finance (Management) Act*, 1995 and by all other powers enabling me hereby:

- 1. Establish the National Judiciary Services Specialized Supply and Tenders Board;
- 2. Direct that the Board may execute contracts to the value not exceeding K3.0 million for purchases and disposal of property and stores and the supply of works and services.
- 3. Direct that the membership should constitute six (6) members comprising:

(<i>a</i>)	Chairman (ex-officio):	Chairperson of the Judges Court Buildings and Facilities Committee.
	Alternate:	Chairperson of the Judges Planning Committee.
(<i>b</i>)	Member (ex-officio):	Secretary, National Judicial Staff Services.
	Alternate:	Deputy Secretary, National Judicial Staff Services.
(c)	Member (ex-officio):	Registrar, National Court.
	Alternate:	Deputy Registrar, National Court.
(<i>d</i>)	Member (ex-officio):	Director Finance, National Judicial Staff Services.
	Alternate:	Accountant, National Judicial Staff Services.
(e)	Member (ex-officio):	FAS—Infrastructure and Economic Development, Public Investment Program—Department of National Planning and Monitoring.
	Alternate:	AS, Infrastructure Branch (ex—officio) Department of National Planning and Monitoring.

Establishment of National Judiciary Specialised Supply and Tenders Board-continued

(f) Member (ex—officio):	First Assistant Secretary, Accounting Frameworks & Standards, Department of Finance.
Alternate:	Assistant Secretary, Accounting Frameworks, Department of Finance — or Nominee from the Department of Finance appointed by FAS—(ex—officio).

- 4. Direct that the membership forming the quorum should constitute four (4) members of which the member from Finance Department, that member's alternate or that members' appointed nominee must be present; and with no more than one alternate member from the rest of the membership.
- 5. Further direct that in compliance with Part 14, Division 4, 22 & 23 of Finance Management Manual the Board is required to provide to the Central Supply and Tenders Board with details of their operations for publication in the annual report by 31 March of the current year for the previous calendar year.
