2015 PACIFIC GAMES CUSTOMS AND EXCISE TARIFF EXEMPTIONS

I, GRAND CHIEF SIR MICHAEL OGIO, GCL., G.C.M.G., K. St.J, Governor-General, by virtue of the powers conferred by Section 9(1)(a) of the *Customs Tariff Act 1990* and Section 3(1)(a) of the *Excise Tariff Act (Chapter 107)* and all other powers me enabling, acting with, and in accordance with, the advice of the National Executive Council, hereby reduce to nil rate of import and excise tariff payable on all items specified in Schedule 2 for the 2015 Pacific Games. These rates will expire at 11.59pm on 30th July, 2015, with effect on and from the date of publication of this instrument in the *National Gazette*.
