## REVOCATION AND APPOINTMENT OF ASSISTANT RETURNING OFFICER

THE ELECTORAL COMMISSION, by virtue of the powers conferred by Section 20 of the Organic Law on National and Local-level Government Elections and all other powers it enabling, hereby:-
(a) revokes previous appointment of appointment of Assistant Returning Officers as contained in Government Gazette No. G194 dated 10th May, 2013; and
(b) appoints the persons specified in Column 1 of the Schedule to be the Assistant Returning Officers for the Electorate specified in Column 2 and set out opposite the name of that person in Column 2 and LLGs in Column 3.
