### Notice of 2016 NICTA Budget Under National ICT Act 2009-continued

### **Explanatory Notes:**

*Revenue:* Operational Revenue budgeted for 2016 is K41.1 million. Significant component of this revenue is to be collected from operator license fees, spectrum fees and Satellite resources. These three sources contribute total revenue of K40.2 million.

Disposal of assets and associated revenue is budgeted at K8.8 million.

Arrears Revenue estimated at K6.0 million is budgeted for collection in 2016.

Total revenue, inclusive of operational revenue, asset disposal and arrears is K56.0 million.

Budget Comparison: 2016 versus 2015

Increase of K7.8 million operational revenue in 2016, attributed to increase in Satellite Filing services fees of K7.5 million and K0.3 million from marginal increase in spectrum fees.

Operational Expenditure budgeted for 2016 is K45.2 million. This amount is allocated to six functional departments and the board directors, a total of seven cost Centre's. The total operational expenditure for 2016 increased by K6.0 million or 15.4%, the increase is attributed to increase in corporate overhead costs budgeted for Corporate Services, increase in board retainer/sitting allowances and propose recruitment of new staffs for six functional departments in 2016.

Capital expenditure was decreased to K10.8 million from K15.5 million the previous year. The K4.7 million (30.5%) decrease is attributed to Badihagwa Land acquisition done in 2015 therefore, we only budgeted for development cost for of Badihagwa land for NICTA staff Home Ownership Scheme (HOS) proposed for 2016.

There is no surplus anticipated in the budget for 2016. Any surpluses that materialize during the budget implementation in 2016 will be the result of cost savings or revenue collection exceeding budget.
