- Where, after consultation with any Department authorized to hold land which is not being used, it is determined by the Minister for Lands & Physical Planning or his delegate that authorization of reservation to occupy land be revoked, or any part thereof and shall be done by means of formal advice from the Minister for Lands or his delegate to the affected Department.
- 3. Departments which are not in agreement with the authorizations to occupy reserve land, or revocations thereof (including lands set aside under previous procedures) may appeal to Cabinet.
