APPOINTMENT OF OFFICERS TO APPROVE REQUISITIONS

- I, David Wereh, Secretary for the Department of Works, by virtue of the powers conferred by Section 32 of the *Public Finance (Management) Act*, 1995 and all other powers enabling me, hereby:
 - (a) Revoke all previous Appointments of Officers to Approve Requisitions of the Department of Works hereunder; and
 - (b) Appoint each officer specified in column 1 of the Schedule to approve requisitions for expenditure of moneys with a warrant authority, under Trust or under other authroity for a purpose specified in any column of the Schedule to amounts not exceeding the amount specified in the column opposite the delegation of the officer, to come into effect on or from the date of publication for this Instrument for the Department of Works in the National Gazette.
 - (c) Direct that all requisitions for expenditure of public monies in and by Department of Works shall be endorsed by the respective Admin Officers.
