National Library and Archives (National Library and archives Board) Regulation 1998

APPOINTMENT OF MEMBERS OF NATIONAL LIBRARY AND ARCHIVES BOARD

I, NICK KUMAN, MP, Minister for Education, by virtue of powers conferred by Section 37(1), (2), and (3) of the Act and Section 2(1) and (2) and Section 5 of the Regulation and all other powers me enabling, hereby—

- (a) appoint each person specified in Column 1 of the Schedule to be a member of the National Library and Archives Board;
 - (i) under the Section of the Act specified in Column 2 of the Schedule opposite the name of that person, and
 - (ii) to represent the interests of the offices, organizations and associations specified in Column 3 of the Schedule opposite the name of that person; and
 - (iii) to hold office for the period specified in Column 4 of the Schedule.
- (b) appoint Frank Makanuey, to be the Chairman of the Board under Section 37(3) of the Act.
