Prices Regulation Act (Chapter 320)

#### WATER AND SEWERAGE SERVICES PRICES ORDER 2016 FOR WATER PNG LIMITED

MADE by the Independent Consumer and Competition Commission under Section 21 of the *Prices Regulation Act* (Chapter 320), to come into operation on 1st of May, 2016.

This Prices Order amends the Water and Sewerage Prices Order 2015 for Water PNG Limited (Water PNG) as previously published in the *National Gazette* No. G514 of 14th August, 2015 and the *National Gazette* No. G836 of 23rd December, 2015, and applies from 1st May, 2016.

In this Order:

All conditions for tariff approval contained in the Water and Sewerage Services Prices Order 2015 for Water PNG, as initially published through the *National Gazette* No. G514 of 14th August, 2015 will remain unchanged in this Order except the maximum average prices for water and sewerage services in Schedule 1 will be replaced by this Schedule 1 for the maximum prices for water and sewerage services, in this Prices Order.

Water PNG is required to submit results on its service level measures to the Commission on or before the date as specified by the Commission. The Commission will calculate Service Performance Premiums for Water and Sewerage Services based on the results and will award these Service Performance Premiums to Water PNG to reflect in their tariffs during the following year's annual tariff adjustment. The tariffs shown in Schedule 1 below already include the Service Performance Premiums that were awarded in the transition year, 2015. This will change in the next tariff adjustment based on the actual service performance results submitted by Water PNG.

#### SCHEDULE 1

This Schedule relates to the maximum Water and Sewerage rates for all Water Supply and Sewerage Services supplied by Water PNG. Subject to the abov Conditions for Tariff Approval, the maximum prices which may be charged by Water PNG in respect of any accounts issued on or after 1st May, 2016 (other than arrears which may only be charged at the maximum prices prevailing when those charges were incurred) are as follows:—

In this Order:

All conditions for tariff approval contained in the Water and Sewerage Services Prices Order 2015 for Eda Ranu, as initially published through the *National Gazette* No. G514 of 14th August, 2015 will remain unchanged in this Order except the maximum average prices for water and sewerage services in Schedule 2 will be replaced by this Schedule 2 for the maximum prices for water and sewerage services, in this Prices Order.

Other regulated services included public/ community bulk meters. Eda Ranu can charge any amount so long as the averae price does not exceed the maximum average price of K3.48 per kilo litre for water services.
