NOTICE OF EXEMPTION

COVEC PNG LTD, wishes to engage the services of skilled and experienced non-citizens who are required urgently in the Upgrading and Sealing of Toimonapu to Buin (Kangu wharf) section of the road contract, Contract CSTB 2931, in North Solomons Province.

The exemptions granted in accordance to Section 51 of the *Employment of Non-citizens Act* 2007 are always in the interest of the nation and for a good cause, in the view of the PROJECT'S contribution to the country's development in terms of economic, human resource and infrastructure development, especially infrastructure development.

The exemptions are granted from 2nd May, 2016 to 2nd May, 2019.

Specific conditions placed against the exemptions are:—

- (1) For the company to pay a fee of K3,000.00 for each employee to the Department of Labour & Industrial Relations;
- (2) For the company to register all non-citizen employees that require registration with a professional body;
- (3) For the company to provide employment opportunities (decent work, fair pay, promotions etc) to citizen workers;
- (4) For the company to provide opportunities for human resource development and skills training to its employees.
