CONDITIONS:

- 1. Any land authorized for reservation of occupancy for Special Purposes (Office Complex) and proposed variation will require prior approval in writing of the Secretary of Lands.
- Where, after consultation with any Department authorized to hold land which is not being used, it is determined by the Minister for Lands or his delegate that authorization of reservation to occupy land be revoked, or any part thereof and shall be done by means of formal advise from the Minister for Lands or his delegate to the affected Department.
- Departments which are not in agreements with authorizations to occupy reserve land, or revocations thereof (including lands set aside under previous procedures) may appeal to Cabinet.
