APPOINTMENT OF MEMBERS OF THE TOURISM PROMOTION AUTHORITY BOARD

THE NATIONAL EXECUTIVE COUNCIL, by virtue of the powers conferred by Section 9 of the *Tourism Promotion Authority Act* 1993 and Section 10 of the *Regulatory Statutory Authorities (Appointment to Certain Offices Act* 2004 all other powers it enabling, after receiving recommendation from the Ministerial Executive Appointments Committee, hereby—

- (a) revoke the appointment of members as published in the National Gazette No. G750 of 16th November, 2015; and
- (b) appoint each person specified in Column 2 to be a member of the Tourism Promotion Authority Board under the provisions specified in Column 1 of the Schedule opposite his name to represent the National Tourism interest specified in Column 3 for a period of two (2) years, commencing on and from the date of publication of this instrument in the National Gazette.

APPOINTMENT OF MEMBERS OF THE NATIONAL AIDS COUNCIL

THE NATIONAL EXECUTIVE COUNCIL, by virtue of the powers conferred by Section 7 of the *National Aids Council Act* 1994 and Section 10 of the *Regulatory Statutory Authority (Appointment of Certain Offices) Act* 2004 all other powers it enabling, after receiving recommendation from the Ministerial Executive Appointments Committee, hereby—

- (a) revoke all previous appointments for the National Aids Council members; and
- (b) appoint each person specified in Column 2 of the Schedule to be a member of the National Aids Council appointed under the provision specified in Column 1 of the Schedule opposite his name to represent the organization specified in Column 3, for a period of three (3) years, commencing on and from 24th April, 2013 up to and including 23rd April, 2016.
