APPOINTMENT OF ADMINISTRATOR OF THE REGIONAL PROCESSING CENTRE FOR ASYLUM-SEEKERS

- I, RIMBINK PATO, Minister for Foreign Affiars and Immigration, by virtue of the powers conferred by Section 15D of the *Migration Act* (Chapter 16) and all other powers me enabling, hereby
 - (a) revoke all previous appointments of Administrators at locations described in Paragraph (b); and
 - (b) appoint the occupant of the position with the Immigration and Citizenship Service Authority described as "ICSA 01 Deputy Chief Migration Officer, Refugees and Settlement Division" to be the Administrator of the Regional Processing Centre for asylum-seekers and place of immigration detention located at East Lorengau, Manus Province, at the site formerly known as Portion 244, and the Regional Processing Centre for asylum-seekers and place of immigration detention located at the Papua New Guinea Naval Base in Lombrum, Manus Province,

with effect on and from the date of publication of this Instrument in the National Gazette.

DECLARATION OF PLACES OF IMMIGRATION DETENTION

I, RIMBINK PATO, Minister for Foreign Affiars and Immigration, by virtue of the powers conferred by Section 15B(1)(b) of the Migration Act (Chapter 16) and all other powers me enabling, hereby declare that the Regional Processing Centre for asylum-seekers located at East Lorengau, Manus Province, at the site formerly known as Portion 244, and the Regional Processing Centre for asylum-seekers located at the Papua New Guinea Naval Base in Lombrum, Manus Province, to be the permanent places of immigration detention.
