Associations Incorporation Act

NOTICE OF INTENTION TO APPLY FOR THE INCORPORATION OF AN ASSOCIATION

I, Maria KOYAPO UNDE, of NCD, Port Moresby, National Capital District, Papua New Guinea person authorized by the committee of the association known as:

PNG WIDOWS FOUNDATION INC. (5-104204)

give notice that I intend to apply for the incorporation of the association under the Associations Incorporation Act.

The following are the details of the prescribed qualifications for incorporation as specified in Section 2 of the Act:

- To maintain, promote LADA concepts including pushing for Reformed Widows Act through the National Parliament by way of entering into various Agreements and policies through SPECS means, supported by and between interested international agencies, including NGO, State Government bodies, Business Community, Rural Community, Sales, Press & Media, Academics in ensuring Widow's Movement be legalized, enlisted as part of Millennium Development Goal 2050 and PNG Strategy Vision 2030.
- To establish Widows' Foundation voice at District levels, and to undertake, promote socio-Economic
 programs, projects in the area of Business Act, promote VIII, VBA concepts, counselling and performing
 divine outreach programs, maintain traditional values, support other specific district widow's project
 outlined by the Government Plan.
- 3. To source funding opportunities from relevant stakeholders and Government to encourage conduct financial training, secure loan facilities for the registered widow members and their orphans (children) through existing Widow Life Micro-credit Scheme to improve and sustain their livelihood for their lifetime.
- 4. To secure bank lines of credit facilities in financing, grants, endowments, gifts, donations to be distributed through affiliated widows registered groups nationwide.
- To establish reserve bank and to promote any means to secure funding such as establishing Association's business arms in furtherance of its objectives that shall be managed without the interference of the executive members of the Foundation.

6. To secure bank guaranties, securities or indemnity for payments of money to persons, companies or the payment of liabilities inquired or other obligations to be entrusted into the Foundation in any manner.
