Coffee Industry Corporation (Statutory Functions and Powers) Act 1991

DECLARATION OF RESTRICTED AREAS AND PROHIBITIVE MEASURES TAKEN IN RESTRICTED AREAS, TO ERADICATE, CONTAIN AND MANAGE THE SPREAD OF COFFEE BERRY BORER (CBB) WITHIN PAPUA NEW GUINEA

I, Honorable Assik Tommy Tomscoll, MP, Minister for Agriculture & Live Stock, by virtue of the powers conferred upon me pursuant to Section 4A,6 (1)(C), 20, 21 and 22 of the *Coffee Industry Corporation (Statutory Functions and Powers) Act* 1991, hereby make the following declarations:

1. Restricted Areas

- (a) All Coffee growing provinces within Papua New Guinea are declared "Restrict Areas" for the purposes of eradicating, containing and managing the spread of the pest Coffee Berry Borer (CBB).
- (b) The term "Restricted Areas" for the purposes of this gazette relates to the coffee growing provinces within Papua New Guinea that are identified and declared by the Coffee Industry Corporation Limited, in its official Circulars published through the media outlets from time to time.

2. Prohibitive Measures

- (a) All coffee dealers are prohibited on the purchase or sale of unprocessed coffee in the "Restricted Areas" except with consent of the Coffee Industry Corporation Limited.
- (b) The Coffee Industry Corporation Limited apart from its inspections powers conferred under Section 12 of the Coffee Industry Corporation (Statutory Functions and Powers) Act 1991, is directed to take the following prohibitive measures:
 - (i) Prevent the transfer of coffee plants or any parts of the coffee plants from being transported out of a restricted area.
 - (ii) Confiscate and dispose of any material used in the transportation of unprocessed or processed coffee that are suspected of being contaminated with the presence of CBB.
 - (iii) Confiscate and dispose of processed coffee tested to have moisture content level above 12%.
 - (iv) Prevent conveyance of processed coffee from "Restricted Areas" to point of export, except with Fumigation Notice certified by the Coffee Industry Corporation Limited.

This declaration will be in force for an indefinite period until revoked by Notice in the National Gazette.
