Plant Disease and Control Act 1953 (Chapter 220)

DECLARATION OF JIWAKA, WESTERN HIGHLANDS, SIMBU, EASTERN HIGHLANDS, ENGA AND SOUTHERN HIGHLANDS PROVINCES AS DISEASE AREAS

- I, Honourable Assik Tommy Tomscoll, MP, Minister for Agriculture and Livestock, by virtue of the powers conferred to me by Section 6 and Section 16 of the *Plant Disease and Control Act* 1953 (Chapter 220) and all other powers enabling me, hereby;
 - 1. Declare Jiwaka, Western Highlands, Chimbu, Eastern Highlands, Southern Highlands and Enga Provinces as "Disease Area" due to an incursion of coffee berry borer (Hypothenemus hampei).
 - Prohibit the movement of coffee cherries parchment and green beans with moisture content above 11% and alternative conveyances of CBB out of the "Disease Area" into non-infested areas of Jiwaka, Enga, Southern Highlands, Western Highlands, Chimbu and Eastern Highlands Provinces and of Papua New Guinea.
 - 3. Destroy all infested coffee bean and coffee plants in the "Disease Area".
 - 4. Authorise the Chief Inspector of Plants to make any declarations within the "Disease Area" as required under the *Plant and Disease Control Act* 1953 (Chapter 220) for the effective control and Management of the pest.
