DECLARATION OF WATER AND SANITATION DISTRICT

I, Honorable William Duma, CMG, MP, Minister for Public Enterprises and State Investments by virtue of the powers conferred by Section 6 (1) (a) and (b) of the National Water Supply and Sanitation Act 2016 and all other powers me enabling, on the recommendation of the Water PNG Ltd, hereby declare the area specified in the Schedule to be the Goroka Water and Sanitation District.

SCHEDULE

GOROKA DISTRICT

All that piece of land situated in the Administrative District of Eastern Highlands commencing at the intersection of the north-eastern boundary of the Old Asaro Road with the left bank of the Mumoka Creek and bounded thence on the north by part of the said left bank of the Mumoka Creek generally easterly for approximately 4,970 links and bounded thence generally on the east by straight lines bearing 137 degrees 30 minutes for 596 links 236 degrees for 1,193 links to a flat topped ridge known as Fumi Laveka and by a straight line bearing 153 degrees 30 minutes for 6,512 links to the crest of a grassed spur known as Gardnozovo and crossing the said spur by strigaht lines bearing 91 degrees for 124 links 126 degrees for 179 links and by straight lines bearing 225 degrees for 1,243 links and 205 degrees 30 minutes for approximately 900 links to the generally eastern boundaries of Section VII and following respectively part of the generally eastern boundaries of Section VII aforesaid and the generally eastern boundaries of UAL50 to the Goroka-Kainantu Road and crossing the said Goroka-Kainantu Road to the easternmost corner of Allotment 7 Section V and by the south-eastern boundary of the said Allotment 7 of Section V

bearing 45 degrees 50 minutes for approximately 530 links to the edge of the terrace and by the edge of the terrace aforesaid generally westerly for approximately 3,800 links to a point on the northern boundary of UAL 65 and bounded thence again on the north again on the east and again on the south by part of the boundaries of the said UAL 65 being straight lines bearing 60 degrees for 830 links 173 degrees for 4,260 links and 252 degrees for 1,191 links and bounded thence again on the east and again on the south by part of the boundaries of UAL 162 bearing generally 154 degrees following a gully for a direct distance of 2,260 links and 242 degrees for 1,094 links to a point on the eastern boundary of the Goroka South Airstrip and bounded thence again on the east again on the south and on the west including the Goroka South Airstrip by straight lines bearing 176 degrees 30 minutes for 1,279 links 266 degrees 30 minutes for 1,655 links and 356 degrees 30 minutes for 2,386 links and bounded thence again on the south again on the west and again on the north and including UAL 33 being straight lines bearign 266 degrees 30 minutes for 3,438 links 356 degrees 30 minutes for 8,317 links and 86 degrees 30 minutes for 1,647 links to the westernmost corner of UAL 148 and bounded thence on the north-west by north-western boundary of UAL 148 aforesaid being a straight line bearing 35 degrees 30 minutes for 1,243 links and by a straight line distant approximately 1,990 links to the easternmost point of intersection of the Hospital Road with the aforesaid Goroka-Kainantu Raod and by part of the south-eastern boundary of the Hospital Road aforesaid being a straight line bearing 61 degrees for 1,740 links and bounded thence again on the west by straight lines bearing 350 degrees 30 minutes for 1,059 links 357 degrees 30 minutes for 651 links 351 degrees for 905 links 304 degrees 30 minutes for 149 links and 339 degrees for 298 links to the center of a three pronged road junction and bounded thence on the south-west and again on the south by straight lines bearing 310 degrees for 756 links 268 degrees for 994 links to a point on the north-eastern boundary of the Goroka-Kainantu Road aforesaid and bounded thence again on the south-west by part of the said north-eastern boundary of the Goroka-Kainantu Road aforesaid and bounded thence again on the south-west by part of the said north-eastern boundary of the Goroka-Kainantu Road and part of the north-eastern boundary of the Old Asaro Road aforesaid being straight lines bearing 327 degrees form1, 113 links 2 degrees for 1,203 links and 316 degrees for 452 to the point of commencement be the said several dimension all a little more or less and all bearings true.
