WATER AND SEWERAGE SERVICES PRICES ORDER 2019 FOR EDA RANU

MADE by the Independent Consumer and Competition Commission ("Commission") under Section 21 of the *Prices Regulation Act* (Chapter 320), to come into operation on 1st January, 2019.

In this Order:

NCD Water and Sewerage Limited ("Eda Ranu") has not proposed any new rates for 2019 to the Commission by 1st December, 2018, therefore, since (CPIt+Xt) > 0, the tariffs for water and sewerage services including miscellaneous services will not change on 1st January, 2019.

The tariffs Eda Ranu shall apply from 1st January, 2019 for its Water and Sewerage Services shall be the same as the tariffs published by the Commission in *National Gazette* No. G965 of 2017.

Eda Ranu is required to adopt these tariffs for the regulatory year ending 31st December, 2019.
