PRICE CONTROL ACT

(No. 6 of 1982)

THE PRICE CONTROL (APPLICATION TO GOODS AND RESTRICTION OF PRICES) (AMENDMENT) (NO. 2) ORDER 1996

IN EXERCISE of the powers conferred by sections 4 and 6 of the Price Control Act, 1982, and after consultation with the Prices Advisory Committee, I, CHRISTOPHER COLUMBUS ABE, Minister of Finance, do hereby make the following Order -

1. This Order may be cited as the Price Control (Application to Goods and Restriction of Prices) (Amendment) (No. 2) Order, 1996, and shall be deemed to have come into effect on 22nd day of January 1996.
2. Schedule 3 to the Price Control (Application to Goods and Restriction of Prices) Order 1987* is hereby amended by deleting serial No. 3 and inserting instead the following new serial No. 3 -
" 3 FISH.
