LABOUR ACT (Cap. 75)

THE LABOUR (MINIMUM RATES OF WAGES) ORDER 1996

WHEREAS I have consulted with the representative of the employers and workers.

AND WHEREAS I am satisfied that the minimum rate of wages in force by virtue of the Labour (Minimum Rates of Wages) Order 1988 is unreasonably low.

THEREFORE in exercise of the powers conferred by Section 28 of the Labour Act, I, GEORGE LUIALAMO, Minister for Commerce, Industries and Employment hereby make the following Orde:

- This Order may be cited as the Labour (Minimum Rates of Wages) Order 1996.
- 2. This Order shall come into operation on the 1st day of February 1996.
- The minimum rate of wage for all workers specified in this Order shall be one dollars fifty cents (\$1.50) per hour.

This Order shall apply throughout the Solomon Islands.
