THE BEE INDUSTRY ACT 1994 (No. 2 of 1994)

THE BEE INDUSTRY (PROHIBITION ON IMPORTATION OF BEE, BEE PRODUCTS AND USED APPLIANCES) (AMENDMENT)

REGULATION 1996

IN exercise of the powers conferred by section 3(2) (a) of the Bee Industry Act. 1994 I, VICTOR NGELE, Minister of Agriculture and Fisheries, do hereby make the following regulation -

- 1. This Regulation may be cited as the Bee Industry (Prohibition on Importation of Bee, Bee Products and Used Appliances) (Amendment) Regulation 1996.
- 2. Regulation 3(3) of the Bee Industry (Prohibition on Importation of Bee, Bee Products and Used Appliances) Regulations 1996* is hereby amended by inserting a full stop after the word "appliance" and deleting the words "is prohibited."
