LOCAL GOVERNMENT ACT (Cap. 14)

HONIARA LITTER (PUBLIC AND PRIVATE NUISANCE) (AMENDMENT) BY-LAW 1996

In exercise of the powers conferred by Section 50 of the Local Government Act the Honiara Town Council hereby makes the following by laws.

- 1. These By-laws may be cited as the Honiara Litter (Public and Private Nuisance) (Amendment) By-laws 1996 and shall come into operation on the date of publication in the Gazette.
- 2. The Honiara Litter (Public and Private Nuisance) By-laws 1996 herein after referred to as the principal By-Laws) are hereby amended by inserting immediately after by-law 4 the following new by-laws:-
 - "4A No person shall foul a public place:-
 - (a) by urinating or defecating in or onto it; or
 - (b) in any other manner.
 - 4B No person shall light a fire in a public place other than for the purpose of a Barbecue unless prohibited under any other by-laws of the Council.
 - 4C Any person who contravenes or fails to comply with these by-laws is guilty of an offence and liable to "an on the spot" fine of \$20 00 such sum to be paid to the council within 14 days from the date of the offence. The "on the spot" fine shall be reduced to \$2.00 if payment is made immediately."
- 3. by-law 5(1) of the principal By-laws is hereby repealed and the following new by-law 5(1) substituted therefore:

- "5(1) If the litter or any other substance likely to contribute a nuisance is found in a street or public place or any overgrown grass on any land within seven metres of any premises which has direct access to and which fronts, adjoins or abute such streets or pubic place or land an authorized person may by notice in writing served on the occupier of such premises require him to remove therefrom the litter or substance or cut overgrown grass within such time as ma, v be specified in the notice,"
- 4. The principal By-laws are hereby amended by inserting immediately after by-law 5 the following by-law 5A.
 - "5A Any person who contravenes or fails to comply with this by-law is guilty of an offence and liable to an on the spot"fine of \$50.00 such sum to be paid to the Council within 14 days from the date of the offence and payment of any expenses incurred by the Council."
- 5. The principal By-laws are hereby amended by inserting immediately after by-law 6 the following new by-laws 6A and 6B respectively:
 - "6A every owner of premises shall provide and maintain, to the satisfaction of the Council a sufficient number of receptacles as may, in the opinion of the Health Inspector, be necessary for the reception of litter from such premises. All litter must be placed inside the receptacle.
 - Any person who contravenes or fails to comply with this by-law is guilty of an offence and liable to "an on the sport fine" of \$20.00 such sum to be paid to the council within 14 days from the date of the offence".
- 6. by-law 7 of the principal by-law is hereby repealed and the following new by-law 7 substituted therefore:
 - "7 An authorized person may make enquiries at all reasonable times and place including requiring a vehicle to stop for the purpose of ascertaining whether there is or has been a contravention of these by-laws, including requiring a statement of name and address and may at all

reasonable times and if required, upon production of his authority enter into or upon any land, buildings or premises for the purpose of carrying out any inspection inquiry or the execution of works under the provisions of this by-law"

- 7. by-law 9 of the principal by-laws is hereby repealed and the following new by-law 9 substituted therefore:
 - Where a person denies contravening the provisions of these by-law or fails to pay the "on the spot fine" such person may be charged under these by-laws and upon conviction be liable to a fine not exceeding \$100.00, plus in the case of a continuing offence \$5.00 per day together with in the case of non-compliance of a notice served in accordance with By-law 5(1), (2) or (3) payment of the whole or part of any such expenses incurred by the Council and in default of payment, to imprisonment for 3 months".

HONIARA (LICENSING OF BUSINESSES)(AMENDMENT) BYE-LAWS1997

- 1. These Bye-laws maybe cited as the Honiara (Licensing of Businesses) (Amendment) Bye-Laws 1997and shall come into operation on the 1 st day of January 1997.
- 2. The Schedule to the Honiara (Licensing of businesses) (Amendment) Bye-laws 1990* is hereby deleted and the following new Schedule substituted therefore...
