THE ELECTRICITY (AMENDMENT) REGULATION 1997

IN exercise of the powers conferred by section 56 of the Electricity Act, I. DAVID VOUZA. Minister of Energy, Mines and Minerals, do hereby make the following regulations -

1. This Regulation may be cited as the Electricity (Amendment) Regulation
