### WORK PERMIT RULES 1985 WORK PERMIT (AMENDMENT) RULES 1997

- 1. These Rules may be cited as the Work Permit (Amendment) Rules 1997.
- 2. Sub-rule 3 of Rule 7 of the Work Permit Rules (hereinafter referred to as the "principal rules") is hereby amended by deleting the words "two hundred and fifty" thereof and substituting therefor the words "five hundred".
- 3. The Principal Rules are by amended by deleting Schedule 2 thereof and substituting therefor the following schedule -
