APPOINTMENT OF MESSRS WARREN PAIA AS A CONCILIATOR IN THE TRADE DISPUTE CASE BETWEEN THE SOLOMON ISLANDS NURSES ASSOCIATION AND SOLOMON ISLANDS GOVERNMENT.

PURSUANT TO SECTION 4 (5) OF THE TRADE DISPUTES ACT 1981, I ANGELINA NUATALI TONGARUTU, CHAIRMAN OF THE TRADE DISPUTES PANEL HEREBY APPOINT YOU MESSRS WARREN PAIA TO ACT AS A CONCILIATOR IN THE DISPUTE BETWEEN THE SOLOMON ISLANDS NURSES ASSOCIATION AND THE SOLOMON ISLANDS GOVERNMENT.

 Your main duty is to facilitate the negotiations between the parties and to offer your assistance in advising the parties on the best approach to the settlement of the Association's claims.

- 3. At the conclusion of the conciliation process you shall advice the Panel in writing of the outcome thereof.
- 4. Your appointment is for the duration of one month with effect from the date stated hereinunder.
