### THE WESTERN PROVINCE 2001/2002 APPROPRIATION ORDINANCE

#### AN ORDINANCE TO

Appropriate Thirteen millions Seven hundred and Fifty One Thousand, Seven Hundred and Ninety Nine Dollars to the service of the financial year ending 31st March, 2002.

Enacted by the Western Provincial Assembly with Assent of the Minister as follows:

- 1. This Ordinance may be cited as the Western Province 2001/2002 Appropriation Ordinance 2001 and shall come into EFFECT on the date it is assented to by the Minister in accordance with section 30 of the Provincial Government Act 1997.

### THE CITIZENSHIP ACT 1978 (NO. 7 OF 1978)

# THE CITIZENSHIP (APPEAL PROCEDURES) REGULATIONS $2000\,$

IN exercise of the powers conferred by section 13 of the Citizenship Act, 1978, the Minister hereby makes the following regulations -

- 1. These Regulations may be cited as the Citizenship (Appeal Procedure) Regulation 2000.
- 2. Any person aggrieved by any decision of the Commission which relates to his application may appeal to the Minister in writing within thirty days from date of notification of the Commission's decision.

- 3. Every appeal to the Minister shall be submitted with the prescribed filing fees and shall be filed with the office of the Minister,
- 4. (1) Every notice of appeal shall be in writing and shall contain the grounds of appeal as stipulated under section 12 of the Act as well as the Schedule to these Regulations.
- (2) The ground of appeal must arise from any decision of the Commission or part thereof and not otherwise, unless in the opinion of the Minister, regulation 6 of these procedures maybe invoked.
- 5. New ground of new materials which were not relevant to or considered by the Commission when deciding on an appellants application must not be included as grounds of appeal, subject to regulation 6 of these procedures.
- 6. Where circumstances warrant, and if it is the sole opinion of the Minister that the appellant may, if granted Citizenship contribute positively towards an immediate crisis which is of national interest, the Minister may under very exceptional circumstances, uphold an appeal. Such approval shall not be regarded in anyway as precedence only that it shall be regarded as circumstantial where an incidental of national interest dictates such circumstance, therefore applicable only for a period of time which in the opinion of the Minister justifies.
- 7. Within 7 days of filing his notice of appeal, the appellant must file written submissions in support of his appeal.
- 8. (1) Within 7 day of receiving the grounds of appeal and submissions, the Minister shall cause a copy of these documents to be served on the Secretary to the Commission.
- (2) The Secretary shall, within seven days of being served with the grounds and submissions, cause its case file and written submission to be lodged with the Minister.
- 9. Where an appeal has been lodged, the appellant, his relatives, friends, agents or servants; and the Chairman, Commissioner on representations of the Commission, shall not, in any way communicate with the Minister regarding the appeal,

- 10. (1) The Minister shall, within thirty days of receiving the notice of appeal, notify the appellant and the Commission of his decision and the reasons for such a decision.
- (2) The Minister shall either uphold or Dismiss the appeal and his decision shall be final and not subject to any further appeal in any court of law.
