HONIARA CITY COUNCIL (2011 APPROPRIATION CONSEQUENTIAL AMENDMENT) ORDER 2010

WHEREAS pursuant to sections 6 and 9 of the Honiara City Act, the election of members of the Honiara City Council was due to have been held on 27 August 2010 after the Council was dissolved at midnight on 26 August 2010 on the expiration of the term of four years of the Council after the last election;

WHEREAS the holding of the general elections for National Parliament during the same period did prevent or hinder the holding of the election on 27 August 2010, as required under the Honiara City Act;

WHEREAS the next election of members of the Honiara City Council is due to be held on 8 December 2010 (Legal Notice 137 of 2010);

WHEREAS to ensure the proper functioning of Honiara City Council, estimates of the revenue and expenditure of the Council for the 2011 financial year must be approved and related Ordinances enacted by the Council by 1 January 2011;

WHEREAS certain fees, rates and charges need to adjusted, as a result of the 2011 estimates of the revenue and expenditure of the Council reflected in the Honiara City Council (2011 Appropriation Order) 2010, and it is essential that these adjustments come into force by 1 January 2011;

I THEREFORE make this Order pursuant to section 72 of the Act due to the unforeseen and special circumstances set out in the recitals above to amend the Honiara City Council (Fees, Rates and Charges) Ordinance 2009 –

Citation

- 1. (1) This Order may be cited as the Honiara City Council (2011 Appropriation Consequential Amendment) Order 2010 and commences on 1 January 2011.
 - (2) This Order may be replaced by an Ordinance made by the new Council.

- **2.** Schedule 1 of the Honiara City Council (Fees, Rates and Charges) Ordinance 2009 is amended as follows:
 - (a) the fourteenth item under 'Market Services' (titled "Ice Block - All Markets') is amended by deleting the figure "\$45" and substituting the figure "\$50".
 - (b) the twenty third item under 'Market Services' (titled 'Rental Lock Up Shops Kukum') is amended by deleting the figure "\$1,600" and substituting the figure "\$1,000".
 - (c) the fourth and fifth items under 'Planning' (titled 'Issue of Excavation Permits' and 'Issue of Building Certificate') are repealed and replaced with the following items:

uthorisation and propriation of :3,846,804

2. (1) The issue from the City Fund of a sum of \$23,846,804 (Twenty Three Million, Eight Hundred and Forty-Six Thousand and Eight Hundred and Four Dollars) is authorised, to be applied to the service of the year ending 31-December 2011.

(2) The sum specified in subparagraph (1) shall be appropriated for the supply of the heads specified, and in the amounts respectively specified in relation to such heads, in the Schedule.

(3) The 2011 Estimates of revenue and expenditure are deemed to have been laid before the City Council and recommended by the respective Standing Committee.
