## THE GCADALCANAL PROVINCE BASIC RATE (AMENDMENT) ORDINANCE 2010 <br> AN ORDINANCE TO AMEND THE GLADALCANAL PROVINCE BASIC RATE (AMENDMENT) ORIDNANCE 1987

ENACTED by the Guadalcanal Provincial Assembly with the assent of the Minister of Provincial Government and Institutional Strengthening as follows:

1. This Ordinance may be cited as the Guadalcanal Basic Rate (Amendment) Ordinance 2010 and will come into effect when assented to by the Minister in accordance with section 30 of the Provincial Government Act 1997.
