## IMMIGRATION ACT (CAP. 60)

## DECLARATION OF PROHIBITED IMMIGRANT ORDER

IN exercise of the powers conferred upon me by section 11(2)(g) of the Immigration Act, I hereby order and declare the following group of persons as prohibited immigrants after having being convicted of an offence under the laws of Solomon Islands, and hereby declare that their presence in Solomon Islands is unlawful and also shall, after departing Solomon Islands, be prohibited from entering Solomon Islands –
