## CUSTOMS AND EXCISE ACT (CAP. 121)

#### CUSTOMS AND EXCISE (IMPORT DUTY) (AMENDMENT) ORDER 2012

IN exercise of the powers conferred upon me by section 7 of the Customs and Excise Act, I, RICK NELSON HOUENIPWELA, Minister of Finance and Treasury, do hereby make the following Order –

- 1. This Order may be cited as Customs and Excise (Import Duty)
  (Amendment) Order 2012 and commences on the date of publication in the Gazette.
- 2. The First Schedule to the Customs and Excise Act, entitled "IMPORT CLASSIFICATION AND TARIFF" is hereby amended in the following respects
  - (a) by deleting the duty rate of "12.5%" per kg which appears in respect of tariff item "2401.1000" and substituting there for the duty rate "15%";
  - (b) by deleting the duty rate of "\$512.50" per kg which appears in respect of tariff item "2402.1000" and substituting therefor the duty rate"\$525.30";
  - (c) by deleting the duty rates of "\$1.28" per stick which appears in respect of tariff items "2402.2010", "2402.2020", "2402.9000" and substituting therefor the duty rate "\$1.30" per stick.

- (d) by deleting the duty rate of "\$405.90" per kg which appears in respect of tariff items "2403.1010" and substituting there for the duty rate "\$426.10" per kg.
- (e) by deleting the duty rates of "\$676.50" per kg which appears in respect of tariff items "2403.1090", "2403.9100", 2403.9900" and substituting therefor the duty rate "693.40" per kg.

# CUSTOMS AND EXCISE (EXCISE DUTIES) (AMENDMENT) ORDER 2012
