DEPORTATION ACT (CAP. 58)

DEPORTATION ORDER - STATEMENT OF FACTS

WHEREAS YOU, YANG ZONGMIN, are a person who was issued a visitor's permit under section 9(1) of the *Immigration Act* (Cap. 60) by the Director of Immigration.

WHEREAS the Director of Immigration has cancelled your visitor's permit on the 24th day of April, 2013, and your continuing presence in Solomon contravenes section 11(1) as read with section 6(2) of the *Immigration Act* (Cap. 60).

AND WHEREAS the Director of Immigration has cancelled your visitor's permit under section 9(4)(e) of the *Immigration Act* (Cap. 60) by being involved in bech-de-mer trading without resident permit granted to you by the Director of Immigration under section 8(1) of the *Immigration Act* (Cap. 60).

AND WHEREAS YOU have conducted yourself in a manner prejudicial to peace and public order in Solomon Islands and have thus been declared by the Government as an undesirable immigrant under section 11(2)(f) of the *Immigration Act* (Cap. 60).

AND TAKE NOTICE that the particulars of the facts against you, Yang Zongmin, or upon which this ORDER is made are as follows –

- 1. That you are a foreign national from China.
- 2. That you entered the country on the 26th day of March, 2013 on a visitor's permit which was cancelled by the Director of Immigration on the 24th day of April, 2013 yet you continue to reside illegally in the country until to date.
- 3. That you were found to have engaged in illegal bech-de-mer trading that contravened section 9(2)(b) of the *Immigration Act* (Cap. 60).

NOW THEREFORE pursuant to section 4 of the *Deportation Act* (Cap. 58) as read with section 5(1) of the same Act and having regard to the particulars stated above, I hereby order you, **YANG ZONGMIN**, to leave and thereafter remain out of Solomon Islands.

AND pursuant to section 7(2) of the *Deportation Act* (Cap. 58), I hereby authorize this Order is served on YANG ZONGMIN to place him on board any ship or aircraft leaving Solomon Islands.

AND I further authorize and direct the Officer-In-Charge of the Honiara Rove Correctional Service or Honiara Police Stations in Solomon Islands to detain the said YANG ZONGMIN until arrangements are completed for so placing him on board any ship or aircraft.
