## CUSTOMS AND EXCISE ACT (CAP. 121)

### CUSTOMS AND EXCISE (EXPORT DUTY RATES FOR ROUND LOGS) (AMENDMENT) ORDER 2013

IN exercise of the powers conferred upon me by section 7 of the Customs and Excise Act, I, **Rick Nelson Houenipwela**, Minister for Finance and Treasury, do hereby make the following Order –

1. This Order may be cited as the Customs and Excise (Export Duty Rates) (Amendment) No 3 Order 2013 and shall commence on 1<sup>st</sup> July 2013 and expire on 30<sup>th</sup> September 2013.

2. This Order does not have the effect of allowing the export of species which are prohibited for export as round logs under the Forest Resources and Timber Utilization Act (Cap. 40) or any other Act.

3. The export duty payable on the export of round logs shall be calculated and determined in the manner provided in the Schedule herewith.

4. The First Schedule to the Customs Act under the heading 44.03 entitled "EXPORT CLASSIFICATION" is amended in the following respects –
