HONIARA CITY COUNCIL (MEMBERS' ALLOWANCES) ORDER 2014

IN exercise of the powers conferred upon me by section 15(1) of the Honiara City Act 1999, I make this Order:

Citation and commencement

1. This Order may be cited as the Honiara City Council (Members' Allowances) Order 2014 and commences on the date appointed by the Minister and published in the *Gazette*.

Interpretation

2. In this Order, unless the context otherwise requires:

"member" means a person, excluding the Mayor, elected or appointed to the Council under sections 5 and 7(2) of the Act;

"the Act" means the Honiara City Council Act 1999;

"the Council" means the Honiara City Council established under section 4 of the Act;

"the Order", means the Honiara City Council (Members' Allowances) Order 2014.

Allowances for Members

3. (1) A member of the Council is entitled to the allowances specified in the Order including Schedules to the Order.

(2) The allowances in the Order will be reviewed after a period of five years beginning from the date of commencement of the Order.

Local daily subsistence allowance

4. (1) A member is entitled to a daily subsistence allowance set out under Schedule 1 of the Order when on local official visits to other provinces within Solomon Islands, subject to prior approval of the Council.

(2) A member is entitled to an accommodation allowance when on local official visits provided that:

- (a) the accommodation allowance covers the reasonable costs of accommodation only and shall not include incidentals such as alcohol or other beverages or cigarettes; and
- (b) the Council will only meet costs that are supported by a quotation or invoice of the total cost for accommodation, and such documentation must be submitted prior to the visit, for the Council's approval before payment is made

Overseas daily subsistence allowance

5. (1) Subject to subsection (2), a member is entitled to a daily subsistence allowance set out under Schedule 1 of the Order for official overseas visits which includes attending seminars, conferences, workshops, or for work-related training.

(2) If the seminar, conference, workshop or work-related training is funded by an overseas Government or organisation, the member is entitled to one-fifth of the full allowance set out in the Order.

Outfit allowance

6. The outfit allowance set out under Schedule 1 of the Order shall be paid once in every three years, but only if a member attends a seminar, conference, meeting, workshop or training overseas at least once in the same three-year period.

Revocation

7. This Order replaces any and all previous Orders and legal notices determining allowances for all members of the Council.
