(NO. 2 of 1999)**

**THE HONIARA CITY COUNCIL APPROPRIATION ORDINANCE 2014**

**AN ORDINANCE**

**TO**

Appropriate THIRTY THREE MILLION AND SIX HUNDRED FORTY SEVEN THOUSAND, AND THREE HUNDRED FORTY Dollars to the services of the financial year ending 31st December 2015.

Enacted by the Honiara City Council with the Assent of the Minister as follows:

1. This Ordinance may be cited as the Honiara City Council Appropriation Ordinance 2015 and shall come into effect on the date it is assented to by the Minister of Home Affairs in accordance with section 35 (2) of the Honiara City Act 1999.
2. The issue of the sum of THIRTY THREE MILLION AND SIX HUNDRED FORTY SEVEN THOUSAND, AND THREE HUNDRED FORTY Dollars (\$33,647,340) to the services of the financial year ending 31st December 2015.
3. The sum specified in the preceding section shall be appropriation for the supply of Heads and Subheads specified in the schedules and in the amounts respectively in relation thereto.
