CUSTOMS AND EXCISE (RESTRICTED IMPORTS) (AMENDMENT) ORDER 2017

 - **"10A.** Refrigerators, freezers, air conditions and lamps (incandescent, compact fluorescent, tabular fluorescent) intended for sale, unless, at the time of the import, these products comply with the standards prescribed by the Consumer Protection (Approved Standards for Restricted Electrical Products) Regulations 2016".
