## PRICE CONTROL ACT (Cap. 64)

## PRICE CONTROL (APPLICATION TO GOODS AND RESTRICTION OF PRICES) (AMENDMENT) (NO.15) ORDER 2017

I, **Hon. Elijah Doro Muala,** Minister for Commerce, Industries, Labour and Immigration, under section 6 of the *Price Control Act* (Cap. 64), make the following Order:

- 1. This Order maybe cited as the Price Control (Application to Goods and Restriction of Prices) (Amendment) (No. 15) Order 2017, and commences on 15 May 2017.
- The Price Control (Application to Goods and Restriction of Prices) Order 1987 (Legal Notice 47 of 1987) is amended in Schedule 3 by deleting serial no. 12 (Petroeum Products) and substituting the following:

# IMMIGRATION ACT 2012 (NO. 3 OF 2012)

#### **ON-SHORE CHANGE OF STATUS DIRECTIONS**

I, Mason Henry Fugui, Director of Immigration, under section 18(2) of the *Immigration Act 2012*, issue this Onshore Change of Status Directions specifying the following circumstances where a person who is already present in Solomon Islands and the holder of a visa of a class may apply for a visa of another class that apply to visas:

- (a) the person is a holder of a valid family relationship visa;
- (b) the person is a holder of a valid long term employment visa and is eligible for family relationship visa;
- (c) if the person intends to apply for a long term employment visa the person is a holder of a valid long term visa of another class that apply to visas and has paid the relevant fee;
- (d) if the person intends to apply for family relationship visa–the person is a holder of a valid long term visa of another class that apply to visas and has paid the relevant fee;
- (e) if the person intends to apply fir ab exemption-the person is a holder of a valid long term visa of another class that apply to visas;
- (f) the application for another class of visa has met the prescribed requirements.
