# CUSTOMS AND EXCISE ACT (CAP. 121)

## CUSTOMS AND EXCISE (EXPORT DUTY RATES FOR ROUND LOGS) (FOURTH QUARTER) (AMENDMENT) ORDER 2018

I, Hon. **Manasseh Damukana Sogavare**, Minister for Finance and Treasury, under section 7 of the *Customs and Excise Act* (Cap. 121), make the following Order:

#### 1 Citation

This Order may be cited as the Customs and Excise (Export Duty Rates for Round Logs) (Fourth Quarter) (Amendment) Order 2018.

#### 2 Commencement

This Order commences on the date this instrument is published in the *Gazette*.

## 3 Prohibited species

This Order does not have the effect of allowing the export of species which are prohibited for export as round logs under the *Forest Resources* and *Timber Utilization Act* (Cap.40) or any other Act.

### 4 Export duty listed in Schedule

The export duty payable on the export of round logs shall be calculated and determined according to the Schedule to this Order.

#### 5 Amendment of First Schedule

The First Schedule to the *Customs and Excise Act* (Cap.121), as replaced by Legal Notice No. 66 of 2018, is amended in tariff item number **44.03** by replacing the rates of the previous Order with the rates in the Schedule to the Order.
