## CUSTOMS AND EXCISE ACT (CAP. 121)

## CUSTOMS AND EXCISE (IMPORT DUTIES) (AMENDMENT) ORDER 2019

- I, Hon. **Harry Degruit Kuma**, Minister for Finance and Treasury, under section 7 of the *Customs and Excise Act* (Cap. 121), make the following Order:
- 1. This Order may be cited as Customs and Excise (Import Duties) (Amendment) Order 2019 and commences on 1 September 2019.
- 2. The First Schedule to the *Customs and Excise Act* (Cap. 121) is amended as follows:
  - (a) in respect of tariff items "2401.1000, 2401.2000 and 2401.3000", by deleting duty rate "\$1505.19" per kg and substituting "\$2558.823" per kg;
  - (b) in respect of tariff item "2402.1000", by deleting duty rate "\$1505.19" per kg and substituting "\$2558.823" per kg;
  - (c) in respect of tariff item "2403.1100", by deleting duty rate "\$1505.19" per kg and substituting "\$2558.823" per kg; and
  - (d) in respect of tariff items "2403.1910, 2403.1920, 2403.1930, 2403.1940, 2403.1990, 2403.9100, 2403.9910, 2403.9920 and 2403.9990" by deleting duty rate "\$1505.19" per kg and substituting "\$2558.823" per kg.

## CUSTOMS AND EXCISE (EXCISE DUTIES) (AMENDMENT) ORDER 2019
