**PRICE CONTROL ACT
(CAP. 64)****PRICE CONTROL (APPLICATION TO GOODS AND RESTRICTION
OF PRICES) (AMENDMENT) (NO.23) ORDER 2019**

IN exercise of powers conferred upon me by Sections 4 and 6 of the Price Control Act, I make this Order -

1. This Order may be cited as the Price Control (Application to Goods and Restrictions of Prices) (Amendment) (No.23) Order 2019 and shall be effective on the 1st of December 2019.
2. The Price Control (Application to Good and Restriction of Prices) Order 1987 (Legal Notice No.47 of 1987) is amended in Schedule 3 by revoking serial No.13 (Petroleum Products) and substituting the following -

“13 PETROLEUM PRODUCTS

(a) Petroleum Motor Spirit _ (PMS)	696.22	885.6

(c) Kerosene – (KERO)	646.50	(maximum percentage mark-up) - cost into store plus 15% for sales of packaged product - cost into store plus 20% for break bulk sales.”

PRICES) (AMENDMENT) (NO.24) ORDER 2019**

IN exercise of powers conferred upon me by sections 4 and 6 of the Price Control Act, I make this Order –

1. This Order may be cited as the Price Control (Application to Goods and Restrictions of Prices) (Amendment) (No.24) Order 2019 and shall come into effect on the 15th December, 2019.
2. The Price Control (Application to Good and Restriction of Prices) Order 1987 (Legal Notice 47 of 1987) is amended in Schedule 3 by revoking serial No.12 (Liquid Petroleum (Gas) and substituting the following –

“12 LIQUID PETROLEUM GAS
