**THE HONIARA CITY COUNCIL APPROPRIATION
ORDINANCE 2019**

ENACTED by the Honiara City Council with the Assent of the Minister as follows:

1. This Ordinance may be cited as the Honiara City Council Appropriation Ordinance 2019 and shall come into effect on the date it is assented to by the Minister of Home Affairs in accordance with section 3 (2) of the Honiara City Act 1999.
2. The issue of the sum of FORTY FIVE MILLION, TWO HUNDRED THOUSAND AND THREE HUNDRED NINETY FIVE DOLLARS AND SIXTY ONE CENT to the services of the financial year ending 31st December 2019.
3. The sum specified in the preceding section shall be appropriated for the supply of Heads and Subheads specified in the schedule and in amounts respectively in relation hereto.
