3 Exemption from quarantine period

 - (c) be transported from Honiara International Airport to the Heritage Park Hotel, and from the hotel to the airport, in accordance with the

Government's quarantine procedures.

I, **Hon. Manasseh Damukana Sogavare**, Prime Minister, under regulation 7 of the *Emergency Powers (COVID-19)(No. 3) Regulations 2020* (Legal Notice 104 of 2020), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exemption from Quarantine Period)(No. 18) Order 2020.*

2 Commencement

This Order commences on the day it is published in the Gazette.

3 Exemption from quarantine period

- (1) The following persons are exempted from being quarantined at quarantine station for the quarantine period when they enter Solomon Islands on 19 November 2020:
 - (a) Helen Marie Nolan;
 - (b) Philip Michael Drew.
- (2) The exemption under subparagraph (1) is subject to the condition that each person exempted must:
 - (a) on entry into Solomon Islands give to an immigration officer a report certifying that:
 - the person has not been outside Kiribati at any time during the 21 day period immediately before the day the person travels to Solomon Islands; and
 - (ii) Kiribati is a country where there has never been confirmed case of a person infected with COVID-19; and
 - (b) while in Solomon Islands:
 - (i) maintain physical isolation from any other person; and
 - (ii) be accommodated in Honiara at the Heritage Park Hotel in a manner that physically isolates the person from an other person;

and

(iii) be transported from Honiara International Airport to the Heritage Park Hotel, and from the hotel to the airport, in accordance with the Government's quarantine procedures.
