1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exception for Entry into Solomon Islands)(No. 51) Order 2020.*

2 Commencement

This Order commences on the day it is published in the Gazette.

3 Non-citizens who may enter Solomon Islands

Each of the following persons may enter Solomon Islands on 28 December 2020 and 29 December 2020 despite the prohibition under regulation 7(1) of the Regulations:

- (a) Ian Mark Purdie;
- (b) Claudia Louise Walding;
- (c) Warren Danford Michael;
- (d) Susan Jean Henry;
- (e) Deborah Denise Rasmussen;
- (f) Jasmine Nyora-Jade Host.

EMERGENCY POWERS (COVID-19)(EXEMPTION FROM QUARANTINE PERIOD)(NO. 21) ORDER 2020

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 9 of the Emergency Powers (COVID-19) (No. 4) Regulations 2020 (Legal Notice 193 of 2020), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exemption from Quarantine Period)(No. 21) Order 2020.*

2 Commencement

This Order commences on the day it is published in the Gazette.

3 Exemption from quarantine period

- (1) The following persons are exempted from being quarantined at a quarantine station for the quarantine period when they enter Solomon Islands on 28 December 2020 and 29 December 2020:
 - (a) Ian Mark Purdie;
 - (b) Claudia Louise Walding;
 - (c) Warren Danford Michael:
 - (d) Susan Jean Henry;
 - (e) Deborah Denise Rasmussen;
 - (f) Jasmine Nyora-Jade Host.
- (2) The exemption under subparagraph (1) is subject to the condition that each person exempted must while in Solomon Islands:
 - (a) maintain physical isolation from any other person; and
 - (b) be accommodated in Honiara at the Heritage Park Hotel in a manner that physically isolates the person from any other person; and
 - (c) be transported from Honiara International Airport to the Heritage Park Hotel, and from the hotel to the airport, in accordance with the Government's quarantine procedures.
