IMMIGRATION ACT 2012

(No. 3 of 2012)

EXEMPT PERSONS

I, Hon. Fredrick Kologeto, Minister for Commerce, Industries, Labour and Immigration, advise that the following non-citizens are exempt from the requirement to hold a visa to enter or stay in Solomon Islands:

- (a) each person specified in Schedule 1, because in accordance section 11(1)(a) of the *Immigration Act 2012*:
 - (i) I am satisfied diplomatic privileges and immunities have been extended in Solomon Islands to the person; or
 - (ii) the person is the family of that person; and
- (b) each person specified in Schedule 2, because in accordance with section 11(1)(b) of the *Immigration Act 2012*:
 - (i) I am satisfied that the person is employed in the service of the Government of Solomon; or
 - (ii) the person is the family of that person.

(No. 3 of 2012)

EXEMPT PERSONS

I, Hon. Fredrick Kologeto, Minister for Commerce, Industries, Labour and Immigration, under section 11(1)(e) and (4)(c) of the *Immigration Act 2012*:
