EMERGENCY POWERS (COVID-19) REGULATIONS 2021

EMERGENCY POWERS (COVID-19)(EXCEPTION FOR ENTRY INTO SOLOMON ISLANDS) (NO. 101) ORDER 2021

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7(3) of the *Emergency Powers (COVID-19) Regulations 2021* (Legal Notice No. 84 of 2021), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19) (Exception for Entry into Solomon Islands) (No. 101) Order 2021.*

2 Commencement

This Order commences on the day it is published in the Gazette.

3 Non-citizens who may enter Solomon Islands

Each person specified in the Schedule may enter Solomon Islands on 2 May 2021 and on 3 May 2021 despite the prohibition under regulation 7(1) of the Regulations.

EMERGENCY POWERS (COVID-19) REGULATIONS 2021

EMERGENCY POWERS (COVID-19)(EXEMPTION FROM QUARANTINE PERIOD)(NO.49) ORDER 2021

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 10 of the *Emergency Powers (COVID-19) Regulations 2021* (Legal Notice 84 of 2021), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers* (COVID-19)(Exemption from Quarantine Period)(No. 49) Order 2021.

2 Commencement

This Order commences on the day it is published in the Gazette.

3 Exemption from quarantine period

- (1) Each person specified in the Schedule is exempted from being quarantined at a quarantine station for the quarantine period when the person enters Solomon Islands on 2 May 2021 and on 3 May 2021.
- (2) The exemption under subparagraph (1) is subject to the condition that each person exempted must while in Solomon Islands:
 - (a) maintain physical isolation from any other person; and
 - (b) be accommodated in Honiara at the Heritage Park Hotel in a manner that physically isolates the person from any other person; and
 - (c) be transported to the Heritage Park Hotel from Honiara International Airport, and from the Hotel to the Airport, in accordance with the Government's quarantine procedures.
