# EMERGENCY POWERS (COVID-19) (NO. 2) REGULATIONS 2021

# EMERGENCY POWERS (COVID-19)(EXCEPTION FOR ENTRY INTO SOLOMON ISLANDS) (NO. 172) ORDER 2021

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 7 of the *Emergency Powers (COVID-19) (No. 2) Regulations 2021* (Legal Notice No. 198 of 2021), make the following Order:

#### 1 Citation

This Order may be cited as the *Emergency Powers (COVID-19) (Exception for Entry into Solomon Islands) (No. 172) Order 2021.* 

#### 2 Commencement

This Order commences on the day it is published in the Gazette.

#### 3 Non-citizens who may enter Solomon Islands

- Each person specified in the Schedule may, on 14 October 2021 and on 15 October 2021, enter Solomon Islands under regulation 7(3) of the *Emergency Powers (COVID-19) Regulations 2021* despite the prohibition under regulation 7(1) of the Regulations.
- (2) Nichola Grant and Deepak Prasad may, on 15 October 2021, enter Solomon Islands under regulation 7(3) of the *Emergency Powers (COVID-19) (No. 2) Regulations 2021* despite the prohibition under regulation 7(1) of the Regulations.
- (3) In addition, Lynda Cook may enter Solomon Islands under regulation 7(4).

# **EMERGENCY POWERS (COVID-19) (NO. 2) REGULATIONS 2021**

# EMERGENCY POWERS (COVID-19)(EXEMPTION FROM QUARANTINE PERIOD)(NO.74 ) ORDER 2021

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 10 of the *Emergency Powers (COVID-19) (No. 2) Regulations 2021* (Legal Notice 198 of 2021), make the following Order:

# 1 Citation

This Order may be cited as the *Emergency Powers (COVID-19)(Exemption from Quarantine Period)(No. 74) Order 2021.* 

#### 2 Commencement

This Order commences on the day it is published in the Gazette.

# **3** Exemption from quarantine period

- (1) Each person specified in the Schedule is exempted from being quarantined at a quarantine station for the quarantine period on entering Solomon Islands on 14 October 2021 and on 15 October 2021.
- (2) Nichola Grant and Deepak Prasad are each exempted from being quarantined at a quarantine station for the quarantine period on entering Solomon Islands on 15 October 2021.
- (3) The exemptions under subparagraphs (1) and (2) are subject to the condition that each person exempted must while in Solomon Islands:
  - (a) maintain physical isolation from any other person; and
  - (b) be accommodated in Honiara at the Honiara Hotel in a manner that physically isolates the person from any other person; and
  - (c) be transported to the Honiara Hotel from Honiara International Airport, and from the Hotel to the Airport, in accordance with the Government's quarantine procedures.
