EMERGENCY POWERS (COVID-19) REGULATIONS 2022 EMERGENCY POWERS (COVID-19)(EXCEPTION FOR ENTRY INTO SOLOMON ISLANDS) (NO. 70) ORDER 2022

I, Hon. Manasseh Maelanga, Prime Minister, under regulation 7(3) of the *Emergency Powers (COVID-19) Regulations 2022* (Legal Notice No. 112 of 2022), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers* (COVID-19)(Exception for Entry into Solomon Islands)(No. 70) Order 2022.

2 Commencement

This Order commences on the day it is published in the Gazette.

3 Non-citizens who may enter Solomon Islands

Each person specified in the Schedule may enter Solomon Islands despite the prohibition under regulation 7(1) of the Regulation.
