1 Citation

This Order may be cited as the *Emergency Powers (COVID-19) (Exception for Entry into Solomon Islands) (No. 15) Order 2022.*

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Non-Citizens who may enter Solomon Islands

Each of the person specified in the Schedule may enter Solomon Islands, under regulation 7(3) of the *Emergency Powers (COVID-19) (No. 3) Regulations* 2021, despite the prohibition under regulation 7(1) of the Regulations.

EMERGENCY POWERS (COVID-19) (NO. 3) REGULATIONS 2021 EMERGENCY POWERS (COVID-19) (EXEMPTION FROM QUARANTINE PERIOD) (NO. 3) ORDER 2022

I, Hon. Manasseh Damukana Sogavare, Prime Minister, under regulation 10 of the *Emergency Powers (COVID-19) (No. 3) Regulations 2021* (Legal Notice No. 318 of 2021), make the following Order:

1 Citation

This Order may be cited as the *Emergency Powers (COVID-19) (Exemption from Quarantine Period) (No. 3) Order 2022.*

2 Commencement

This Order commences on the day it is published in the *Gazette*.

3 Exemption from Quarantine Period

- (1) Each of the person specified in the Schedule is exempted from being quarantined at a Quarantine Station for the Quarantine Period starting, when each of the person specified in the Schedule enter Solomon Islands on 22 February 2022.
- (2) The exemption under paragraph (1) is subject to the condition that each of the person specified in the Schedule is subject to the condition that, each person:
 - (a) maintain physical isolation from any other person; and
 - (b) must wear a face mask at all times.
