AN ACT TO AMEND THE COURT FEES ACT

I assent, GEORGE TUPOU V, 27th August 2010.

BE IT ENACTED by the King and the Legislative Assembly of Tonga in the Legislature of the Kingdom as follows:

1 Citation

- (1) This Act may be cited as the Court Fees (Amendment) Act 2010.
- (2) In this Act, the Court Fees Act (Cap. 12), as amended, is referred to as the Principal Act.

2 Schedules Replaced

The Principal Act is amended by repealing the Schedule and replacing it with the following:
