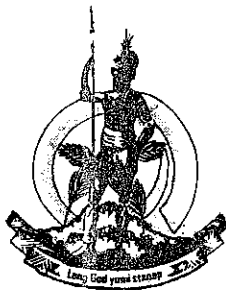

SUPREME COURT OF VANUATU

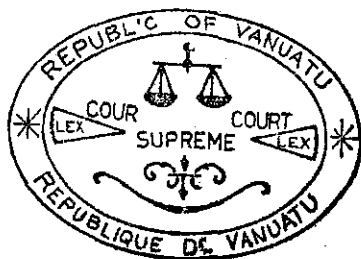
O R D E R

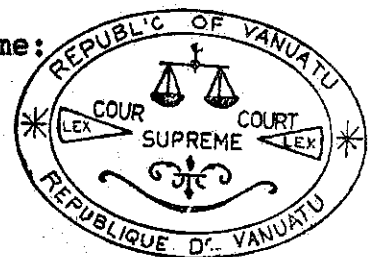
Article 1^{er} : La période des vacances judiciaires de la Cour Suprême est fixée du 1 décembre 1982 au 25 janvier 1983.

Article 45 (4) of the Constitution

In exercise of the power conferred by Article 45 (4) of the Constitution of Vanuatu and being satisfied that the Chief Justice, the Honourable Mr. Justice Frederick G. Cooke, will be absent from the Republic for mid-tour leave from the 28th of October 1982, I Ati George Sokomanu, President of the Republic of Vanuatu, after consultation with the Judicial Service Commission hereby appoint MICHAEL COAKLEY, SENIOR MAGISTRATE, to be an acting Judge of the Supreme Court until the return to the Republic of the Chief Justice or until his appointment is revoked.


