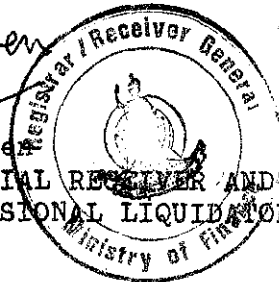

PUBLIC NOTICE

NOTICE IS HEREBY given by the Central Bank of Vanuatu that as from the 1st day of April 1983,

- (a) the Franc Neo-Hébridais in note form shall cease to be legal tender in the Republic of Vanuatu;
- (b) the Central Bank shall undertake to pay the face value of such notes to any person presenting them to the Bank; and
- (c) Australian notes and coins shall not be considered as co-circulating currency in Vanuatu and shall be treated as foreign currency.

Loi n° 3 de 1980 sur la Banque centrale de Vanuatu

[art. 21 (4) (a)]

La Banque centrale de Vanuatu informe le public qu'à partir du 1 avril 1983 :

- a) Le franc néo-hébridais, sous forme de billets, n'aura plus cours en République de Vanuatu ;
- b) La Banque centrale s'engage à échanger ces billets contre leur valeur nominale en faveur de toute personne qui les présentera à la Banque ;
- c) Les billets et les pièces australiens n'auront plus cours à Vanuatu et seront traités comme monnaie étrangère.
