PUBLIC NOTICE

IN EXERCISE of his Constitutional powers the Prime Minister announces the following changes in his Government with effect from the 17th day of March, 1986.

1. The general responsibility for Civil Aviation, Air Vanuatu and matters connected therewith has been transferred from the Minister of Transport, Communication and Public Works to the Prime Minister.
2. The general responsibility for Co-operatives, Rural Business Development and matters connected therewith has been transferred from the Minister of Finance Commerce, Industry and Tourism to the Prime Minister.
3. The general responsibility for Religion, Culture, Charitable Organisations and matters connected therewith has been transferred from the Minister of Home Affairs to the Prime Minister.
4. The general responsibility for Rural and Community Development Centres, Women Affairs, Youth, Scouts, Guides and matters connected therewith has been transferred from the Minister of Education, Youth and Sport to the Minister of Home Affairs. Although the Minister of Home Affairs will still have general political responsibility over Immigration, Immigration will no longer be part of the Vanuatu Police Force and there will be a civilian Department of Immigration.
5. The Minister of Finance, Commerce, Industry and Tourism has been given general political responsibility over Urban Business Development and facilitating outside investments in Vanuatu.
6. The Minister of Foreign Affairs and External Trade has been given general political responsibility for all matters relating to Foreign Aid to the Republic of Vanuatu and to foster and encourage Trade Relationships.
7. The Minister of Education, Youth and Sport has been given general political responsibility for Curriculum Development, Development of University and Higher Tertiary Institutions, Training of Teachers, Technical and Physical Education and matters connected therewith. As a result of these changes the Ministry will now be known as the Ministry of Education and Sport.
8. The general responsibility for Coconut Oil Mills and matters connected therewith has been transferred from the Minister of Agriculture, Forestry and Fisheries to the Prime Minister.
